Simpson Thacher Helps Secure Major Title IX Changes for High School Girls

Simpson Thacher, in partnership with the Legal Aid Society-Employment Law Center and California Women's Law Center, has helped bring about major changes under Title IX for high school girls in Ventura County, California. In May 2015, the Firm and its nonprofit partners sent a demand letter on behalf of female athletes to Santa Paula High School alleging numerous Title IX violations with respect to athletic participation opportunities, treatment and benefits for girls. More specifically, the demand letter alleged athletic gender inequities in Santa Paula's PE and interscholastic athletic programs, including older gyms and locker rooms used for girls, fewer female participants involved in sports, and other gender inequities in the softball facilities, transportation to practices, games, coaches and training. Santa Paula immediately started to explore how to bring its facilities and programs into compliance with Title IX and adopted a resolution reflecting its commitment to gender equity and Title IX compliance. After lengthy negotiations, Santa Paula improved and is maintaining equitable athletic facilities for girls and boys; offering additional girls' athletic teams; increasing outreach to girls to participate in sports; and providing additional Title IX training to its coaches and administrators, among other things. This



is a model resolution involving cooperative efforts by both sides to timely, comprehensively, efficiently and effectively bring positive changes to the girls at Santa Paula High School. Clinic, the litigation seeks to address the inordinate amount of time—nearly four years, on average—a veteran must wait to receive a ruling on an appeal after being denied benefits for service-connected disabilities. The team is being led by Lynn Neuner and Elisa Alcabes, with several associates including Lauren Repole, Michael Brasky and Daniel Cohen.

Earlier this year, attorneys at the Firm were successful in resolving two claims on behalf of veteran clients. In February, the Veteran's Administration (VA) granted our client's disability claim, assigning the highest possible disability rating for Post-Traumatic Stress Disorder (PTSD), which arose from sexual assault she experienced while in the service. The decision substantially increased her monthly payments and allows for retroactive benefit payments. In addition, by granting our client's PTSD claim, the VA has acknowledged the sexual assault that took her decades to report.

The Firm also successfully obtained an award from the VA including substantial monthly disability compensation plus a lump sum in retroactive payments for a Vietnam veteran with PTSD, diabetes and other service-connected disabilities. The attorneys initially represented this former Marine Corps veteran in achieving an upgrade in his discharge status—a necessary predicate to seeking VA benefits. The VA award reflects recognition of our client's dedicated military service, including months of active combat in Vietnam, which left him with multiple physical and psychological wounds.

Both cases were overseen by **Elisa Alcabes**, who received the 2014 Jeremy G. Epstein Award for Pro Bono Service from The City Bar Justice Center for her work on these matters. **Katie McDonough** worked on the first matter and **Michael Brasky** and **Charles Mathes** worked on the second matter.

Recent Pro Bono Achievements

Simpson Thacher Defends Washington Tenant from Eviction

Attorneys in Simpson Thacher's Washington, D.C. office assisted a tenant with keeping his home after he was threatened with eviction from his apartment for multiple alleged lease violations. The landlord dismissed all claims against the tenant with prejudice following a brief monitoring period. The case was referred by Legal Aid of the District of Columbia. The team included **Elliot Weingarten**, **Andy Hasty** and **Peter Thomas**.

Simpson Thacher Secures Asylum for Nigerian Man

Simpson Thacher successfully secured a grant of asylum for a Nigerian man who had been the victim of violence and feared further persecution in his home country because of his sexual orientation. The pro bono matter was referred to the Firm by Immigration Equality, an organization dedicated to supporting LGBT and HIV-positive immigrants seeking safety, fair treatment and freedom. The team included **Rachel Sparks Bradley**, **Kevin Roe**, and **M. Shin** and was supervised by **Olga Gutman**.

Simpson Thacher Wins Appeal on Behalf of California Victim of Domestic Violence

On December 15, Simpson Thacher won its pro bono appeal of the denial of a five-year restraining order renewal for an indigent victim of domestic violence. A panel of the California Court of Appeal unanimously held that the trial court abused its discretion by denying the renewal and instead merely warning the abuser that a new restraining order would issue if he continued his abusive conduct. Simpson Thacher Wins Asylum for Two Ecuadorian Children

Simpson Thacher successfully secured grants of asylum for two unaccompanied minors from Ecuador who had been subjected to years of physical and emotional abuse by their primary caregivers. The pro bono matter was referred to the Firm by Kids in Need of Defense (KIND). The team included **Andrew Dempster, Stephanie Acosta Inks, Adrienne Baxley**, and **Magallie Kortright**, and **Craig Waldman**.

Simpson Thacher Represents National Women's Law Center before the U.S. Supreme Court

Simpson Thacher filed an amicus brief in the United States Supreme Court on behalf of the National Women's Law Center in Whole Woman's Health v. Hellerstedt. The case challenges Texas' statutory requirement that abortion facilities meet certain standards of ambulatory surgical centers and that abortion providers have admitting privileges in a local hospital. Simpson Thacher's brief argued that the right to make reproductive decisions is essential to women's dignity and equality, and that the abortion restrictions at issue infringe on that right, specifically examining the negative effect of such restrictions on women's economic security and opportunities. Simpson Thacher Wins Appeal on Behalf of Mother of Two in a Child Support Matter

On February 23, Simpson Thacher won a pro bono appeal in a child support matter on behalf of a mother of two. The Queens County Family Court had vacated the mother's award of child support, including nearly \$20,000 in arrears, on the basis of objections by the children's father. A panel of the Second Department of the Appellate Division unanimously held that the Family Court erred in granting the father's objections, reinstating the mother's petition. Simpson Thacher Secures Dismissal of Holdover Petition for Low-Income Tenant

Simpson Thacher secured the dismissal of a holdover petition filed against its pro bono client in New York City Housing Court. The client's landlord purported to terminate her lease on the basis of noise complaints and then brought a holdover petition against her in New York City Housing Court when she did not vacate her apartment. The Firm defended the client in the holdover proceeding and asserted counterclaims against the landlord for harassment, nuisance and retaliatory eviction. After months of negotiations with counsel for the landlord, the parties agreed to a stipulation of settlement dismissing their claims with prejudice. The stipulation was so ordered by the Housing Court on December 21, 2015. The team included Bill Russell, Linton Mann, Zander Li and Nathan Sanders.

Simpson Thacher Obtains Special Immigrant Juvenile Status for Siblings from El Salvador

Attorneys from the Washington, D.C. office successfully obtained Special Immigrant Juvenile Status and lawful permanent residency for two siblings who fled gang violence in El Salvador. The Simpson Thacher team had previously obtained the same relief for the siblings' older brother. The matter was referred to the Firm by Kids In Need of Defense. Simpson Thacher Represents Forest Hills Volunteer Ambulance Corps
