Simpson Thacher Donates \$350,000 to Hurricane Recovery Efforts

Simpson Thacher donated \$250,000 to the Texas Access to Justice Foundation's Hurricane Harvey Legal Aid Fund, which provides disaster-related legal aid to victims of the hurricane that hit Houston, Texas in September. Attorneys in the Firm's Houston office also provided legal advice and information to victims of Hurricane Harvey through pro bono work with the Houston Volunteer Law Project.

The Firm also donated \$100,000 to two organizations providing relief and assistance to the citizens of Puerto Rico in the aftermath of the devastation caused by Hurricane Maria. Fondos Unidos de Puerto Rico provides immediate services, including clean water, electrical generators, and food to the affected communities, and LatinoJustice PRLDEF's Legal Aid Fund provides legal services to victims, including to assist affected families with processing benefit and insurance claims through insurers and federal aid agencies.

Simpson Thacher and The Bronx Defenders Win Major Appellate Victory Overturning Family Court Decisions Interfering with Access to Counsel

On June 27, 2017, the New York Supreme Court, Appellate Division, First Department unanimously reversed decisions of the Bronx County Family Court which denied two Simpson Thacher clients the right to share documents with their criminal defense counsel. The Firm's clients faced parallel proceedings in family court and criminal court. Working with The Bronx Defenders, the Firm filed motions asking the family court to clarify that our clients had the right to share these documents related to the family court procedure and communicate freely with their criminal counsel. After the motions were denied, the Firm filed appeals to the First Department, which reversed the family court's decisions on both statutory and constitutional grounds raised by the Firm. Specifically, the First Department held that the Social Services Law did not bar the Firm's clients from sharing with their defense counsel Progress Notes prepared by Administration for Children's Services caseworkers, and held that, "[a]ny other result would violate their First and Sixth Amendment rights."

Simpson Thacher Represents *Amici* Before Supreme Court in *Trump v. Hawaii* & *Trump v. International Refugee Assistance Project*

Simpson Thacher attorneys provided pro bono representation to 23 nonprofit organizations that advocate for immigrant and refugee rights and provide legal services to these groups, filing an *amicus* brief in the consolidated case of *Trump v. Hawaii* & *Trump v. International Refugee Assistance Project*, Nos. 16-1540 and 16-1436. In this appeal, the Respondents sought to keep in place a nationwide preliminary injunction that prevents enforcement of President Trump's revised Executive Order banning immigration from several Muslim-majority countries. In support of these efforts, legal services organizations from all over the country filed an *amicus* brief with the Supreme Court arguing that courts serve a critical role in reviewing actions, that the Executive Order violates the Establishment Clause, and that implementation of the Order would cause irreparable harm. On October 10, the Court vacated the Fourth Circuit's judgment and the Ninth Circuit's judgement and remanded both cases with instructions to dismiss the challenge as moot in light of the President's Proclamation of September 24, 2017.

Simpson Thacher Teams With ACLU to Challenge Federal Restrictions on Contraceptive Coverage

On October 6, the Firm, along with the ACLU, filed a lawsuit against the Trump Administration challenging interim rules issued by the Department of Health and Human Services and other federal agencies that would allow nearly all employers and universities to deny employees and students insurance coverage for contraception if the employer or university has a religious or moral objection. The lawsuit, which Simpson Thacher is handling pro bono, argues that the interim rules infringe upon the Establishment Clause and the Equal Protection Clause by authorizing discrimination against women seeking reproductive healthcare, and violates the Administrative Procedure Act.

The lawsuit has received prominent media coverage in both *The National Law Journal* and *Law360*. The Simpson Thacher team includes **Alexis Coll-Very**, **Linton Mann III**, **Matthew Bricker**, **Julia Heald**, **Lawrence Huang**, **Meredith Karp**, **Marissa Lambert** and **Casey Mathews**.

Blackstone and Simpson Thacher Team Up to Screen Immigrants for Naturalization Eligibility

On October 16, lawyers from Blackstone and Simpson Thacher teamed up to screen 30 individuals to determine their eligibility to naturalize. More than 9 million people in the U.S. are eligible to naturalize, but have not yet done so. Naturalizing brings important benefits to clients, including the right to vote, and protection from removal--a particular concern for immigrants in low-income communities that are highly policed. Recent Pro Bono Achievements

Simpson Thacher Wins Asylum for Haitian Client

On July 10, 2017, Simpson Thacher successfully secured a grant of asylum on behalf of a client who had suffered severe persecution and feared further persecution in his home country of Haiti on account of his sexual orientation. The case was referred to the Firm by Immigration Equality, an organization dedicated to supporting LGBT and HIV-positive immigrants seeking safety, fair treatment and freedom. The team included Associates **Becky Sussman** and **Maddy Sprung-Keyser**. The team was supervised by Associate **Rachel Sparks Bradley** and Partner **Alan Turner**.

Simpson Thacher Successfully Helps a Lawful Permanent Resident Obtain U.S. Citizenship

Attorneys in the New York office successfully represented a client in obtaining her U.S. citizenship. The client had been a lawful permanent resident for a number of years and sought citizenship to solidify her permanent status in the U.S. and to be able to vote in Federal elections. The Simpson Thacher team filed the appropriate application for naturalization, helped the client prepare for her civics test and accompanied her to the naturalization interview. The client was sworn in as a U.S. citizen at an Oath Ceremony in New York. The attorney team included **Mark Brod**, **Dennis De Almeida** and **Michael Yan**.

Simpson Thacher Wins Unemployment Insurance Appeal

On October 30, 2017, Simpson Thacher successfully overturned a decision that required a client to return over \$10,000 in benefits due to an alleged willful misrepresentation. The matter was referred to the Firm by Volunteers of Legal Service, an organization dedicated to providing legal representation for low-income New Yorkers. Palo Alto Summer Associates Ride the Justice Bus

Twelve summer associates in the Palo Alto office participated in an all-day pro bono clinic by riding the Justice Bus to Sonoma, California to assist fifteen low income clients complete naturalization applications. Through the nonprofit, OneJustice, Simpson Thacher partnered with the International Institute of the Bay Area and La Luz Bilingual Center to assist these clients and brought them one step closer to becoming United States Citizens.

Simpson Thacher and Three Firm Lawyers to Be Honored by the Legal Aid Society of New York

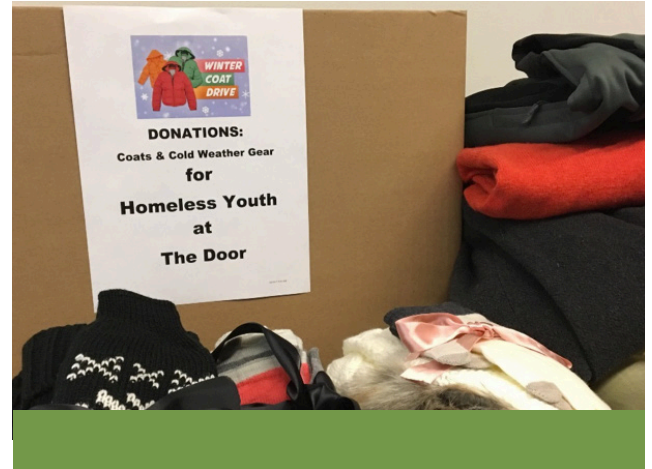

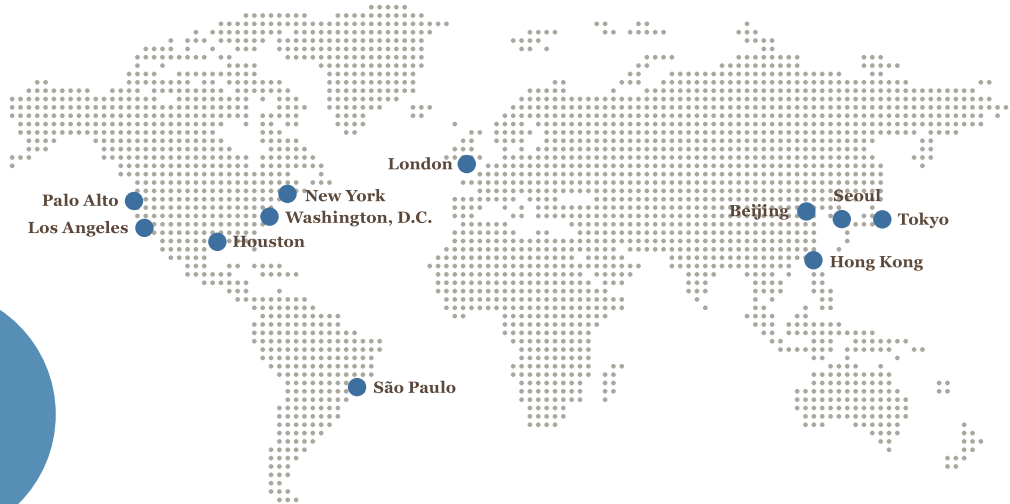
